### ENTRY FORM & SUPPLEMENTARY REGULATIONS

- 1. ANNOUNCEMENT:** The Maharajah's Tour is a Touring Assembly for road registered cars organised by Craven Motor Club and will be held on the 16th of July 2017.
- 2. REGULATIONS:** The event is organised by Craven Motor Club Ltd and Stoke Row Racing Club under a Certificate of Exemption issued by the Motor Sports Association UK Ltd (MSA). The event will be held under the general rules of the MSA as a Touring Assembly and these Supplementary Regulations and any written instructions that the organising clubs may issue for the event
- 3.** The meeting will be held under the General Regulations of the Motor Sports Association (incorporating the provisions of the International Sporting Code of the FIA) insofar as they apply to Touring Assemblies, these Supplementary Regulations and any written instructions that the organising club may issue for this event. A Certificate of Exemption will be obtained from the Motor Sports Association.

- 5. ROUTE:** The route will start at The Fox and Hounds, Theale (RG7 4BE) and finish in Nuffield at the Motorsport Day Show. Navigation will be by tulip road book and marked map. The approximate length will be specified prior to the start but will not exceed 60 miles, if there is enough interest there will be an additional leg of 20 miles finishing at the Cherry Tree Public House, Stoke Row. Route instructions will be issued by the organisers at the start of the event. Please let us know when you enter if you would like the additional loop
- 6. ELIGIBILITY:** All vehicles must be correctly registered and currently licensed with a valid MOT test certificate if relevant. It is the responsibility of all participants to ensure the road worthiness of their vehicle. Trade plates are forbidden. Valid insurance in accordance with the road traffic act is compulsory. Participants and drivers will be obliged to sign a declaration that they are covered by their own insurance. The number of starters will be a maximum of 60, each vehicle will be provided with an individually numbered rally plate, which must be positioned in a forward facing manner.
- 7. INDEMNITY:** All participants must sign any indemnity required under the terms of any policy held by the organisers of the event.
- 8. PETS:** Are not permitted with exception of assistance dogs.
- 9. ENTRIES:** Entries open on publication of these regulations and close one week prior to the event. Entries are accepted on a first come first served basis. The selection of entries is at the absolute discretion of the organisers. All entries will be acknowledged and further instructions issued by e-newsletter or final instructions. Final instructions will be posted to participants no less than one week before the event.
- 10. CANCELLATION:** The organiser reserves the right to cancel or postpone the event or any

part thereof should any circumstances arise which cause such action to be taken. In such circumstances the return of the entry fee in whole or part will be at the organiser's discretion.

- 11. REFUNDS: To withdrawn entries will not be given. Monies will be donated to charity.
- 12. PENALTIES: The Clerk of the Course has absolute discretion in the application and amendment of any penalty for any breach of these regulations and may implement decisions on any matter not provided for by these regulations
- 13. STARTING ORDER: Cars will start in order of manufacture, oldest first.
- 14. AWARDS:- All starters will receive a souvenir award or as specified in the final instructions.
- 15. PATICIPANTS: Must at all times comply with the requirements of the Road Traffic Acts and drive in a responsible and considerate manner to other road users and fellow participants, **this is not a race or timed event**. Please enjoy your car, the countryside and the roads you are travelling on.
- 16. DATA PROTECTION ACT: Prospective entrants and participants are advised that information supplied on the entry form will be held on a computer and used for the administration of the event.
